Notice is hereby given that the meeting of the Executive Committee of the All India Federation of the State Civil/Administrative Service Associations will be held on 24th June, 2023 at 11:00 AM in Punjab Bhawan, New Delhi to transact the following business.

<u>AGENDA</u>

Part- I : General

- 1. To read out and confirm the minutes of the meeting of the Executive Committee held on 24th March, 2023 in Jaipur.
- 2. To place on record the achievements of the outgoing Executive Committee and the stupendous efforts put forth by RAS in hosting the 16th convention of AIF successfully.
- 3. To review the progress on the issues pending before Government of India, DoPT as mentioned in Annexure- 'A', and reconstitution of AIF Core Group. ATR by Federation and State Associations.
- 4. To discuss over the issues to be taken up with GOI in DoPT in view of the resolution No. 1 adopted in General Body Meeting held on 26.03.2023 and to draw out an action plan.
- 5. To discuss over the following issues to be taken up by state associations with their respective state government in view of resolution No. 3 adopted in G.B. meeting:
 - 5.1 That at least 20% post of senior duty posts i.e. Additional Collector /ADM/ADC at District HQ. Collector/DM/DC in District, Head of Departments, Secretary to the Government and Principal Secretary to the Government as provided in IAS cadre of the respective State should be included in the SCS cadre of the respective state to arrest the acute stagnation in the SCS, inordinate delay in promotion from SCS to IAS. The details to be brought by state association in Annexure 'B'.
 - 5.2 Allowing uniform pay scales to the SCS officers across the country as provided for in Model SCS (Pay) Rules, 2023 framed by the AIF through due issue of notification by the State Governments. State association of DANICS, Andhra Parades, West Bengal and Meghalaya are to bring information in annexure 'C'. Association of J.K., Andhra parades, Telangana, Kerala, Maharashtra and Goa are not on board.
 - 5.3 Notification of SCS Rules and Regulations by the State Governments based on the Model SCS Rules and Regulations, 2023 framed by the AIF across the country in a state-specific manner to bring about uniformly and structural reform in administration. The state association to report the progress in Annexure 'D'

- 5.4 Recruitment of SCS officers at Class-I level across the country, the SCS being the premier service in the States. The state association having recruitment of SCS officers at class-II level are to bring the information in Annexure 'E'
- 5.5 Rationalization of SCS cadre strength vis-a-vis IAS cadre strength of different States in the ratio of 1.5:1 meaning thereby, the strength of SCS cadre in a state should not be more than 1.5 times of IAS cadre of that state, as a measure to ensure promotion of SCS officers to IAS at a faster pace.
- 5.6 Complete ban on posting of officers of other services against the cadre posts of SCS officers. The state association to bring the information in Annexure 'F'
- 5.7 Ensuring regular pay scale to the SCS officers on probation specially to SCS officers of Rajasthan, Chhattisgarh and Punjab, as the probationers in these States have been arbitrarily deprived of the regular pay scales and allowances to which they are legally entitled. The concerned association to bring the information in Annexure 'G'
- 6. To discuss over allocation of plot/land for construction of AIF Bhawan-cum-Research and Development centre in Delhi/Gurugram/Noida in view of resolution No 2 of G.B. meeting.
- 7. To discuss over recreation and redesign of AIF website in view of resolution No.6 of G.B. meeting.
- 8. To review the progress over resolution adopted on Bihar Association episode.
- 9. To discuss over replication of the best practices of some States to the States where there are marked deficits in different areas towards promoting better welfare structures for the SCS officers and for cementing the fraternity among the SCS officers across the country.
- 10. To consider and approve the amendment to the Constitution of the Federation on re-organization of Central Region in view of the resolution adopted in EC meeting held on 24 March, 2023.
- 11. To discuss over creating a common symbol for all SCS Officers across the country in terms of,

Necktie and a Scarf to identify as member of one identifiable fraternity.

Part- II : Financial Issues

- 12. Handing over of AIF record by Sh. Lajvir Singh, outgoing Secretary Finance to Smt. Annapurana Alley, Secretary Finance AIF and to Secretary General & Secretary Coordination, AIF.
- 13. To authorise Smt. Annaurana Alley new Secretary Finance AIF to operate the AIF accounts and to file income tax returns on behalf of the Federation.
- 14. To discuss and deliberate on the status of outstanding Affiliation Fees payable to AIF by the SCS Associations with reference to the details given in **Annexure-'H'**. Outstanding fee may please be deposited in the Federation account by 20th June, 2023.
- 15. To discuss the issue of one time settlement of outstanding affiliation-fee for the period from 2000-01 to 2017-18 with reference to the details given in **Annexure-'1**', in case of those state associations willing to clear it.
- 16. To consider and approve the statements of receipt and expenditure of the AIF for the year 2022-23.

17. Any other agenda with the permission of the Chair.
